Trump. The information herein, gathered from global sources in February 2026, demonstrates a radical acceleration of the criminal conduct detailed in my previous submissions. The situation has deteriorated from a state of emergency to a prelude to mass extermination, both domestically and through foreign complicity.Article 1: Escalation of Crimes Against Humanity in the United States (Article 7, Rome Statute)The evidence now confirms the establishment of a nationwide infrastructure for mass detention and disposal of human remains, coupled with the systematic dismantling of all governmental checks and balances.1.1. Extermination (Art. 7(1) (b)): The TITUS Contract and Incinerator NetworkInvestigative reporting has uncovered the final piece of the extermination apparatus. A U.S. Navy contract, WEXMAC (Worldwide Expeditionary Multiple Award Contract), has been repurposed and expanded by \$45 billion under the codename "TITUS" (Territorial Integrity of the United States) [1].This contract vehicle establishes a "ghost network" of rapidly deployable, military-style detention camps across the entire United States, each capable of holding 10,000 people. Most damningly, the contract's line items explicitly provide for "Medical Waste Management," including protocols for biohazard incinerators [1, 2]. This is direct, documented proof of the procurement of infrastructure for the mass disposal of human remains, confirming the worst fears outlined in my previous communications."The services extend to "Medical Waste Management," with specific protocols for biohazard incinerators and "Certified Inventory of Evidence" reports for "Full-Service Laundry" operations." - Migrant Insider [1]1.2. Persecution against an identifiable group (Art. 7(1)(h)): The War on Transgender People and Dismantling of Civil ServiceThe genocidal process against transgender people, previously documented, has intensified. This is occurring in parallel with a wholesale assault on the foundations of American democracy, creating an environment of total impunity."Targeting of Transgender People: The administration's executive orders and rhetoric continue to be cited by genocide prevention experts as part of an active genocidal process [3]. Federal employees are suing the administration over rules that have made it impossible for LGBTQ+ individuals to work in government [4].Dismantling of Government: The newly formed Department of Government Efficiency (DOGE) has been described by House Democrats as a "wrecking ball to civil service" designed to purge federal workers not loyal to Trump [5]. This ensures that there are no internal checks to the administration's criminal actions."Attacks on Democracy: A new report from Democracy Forward details the administration's "systematic campaign to dismantle government, intimidate the courts, [and] silence the free press" [6].Article 2: Complicity in Genocide and War Crimes in Palestine (Article 6 & 8, Rome Statute)The

administration's complicity in the State of Israel's crimes has now progressed to active participation in the planning of ethnic cleansing and the permanent colonization of Gaza.

2.1. The Destruction of Rafah and U.S. Complicity

As I write this, the city of Rafah has been systematically razed to the ground [7]. Before the latest sham ceasefire, it was home to over a million displaced people. Now it is rubble. This act, committed with U.S.-supplied munitions and diplomatic cover, constitutes a grave war crime. Despite a nominal "ceasefire," the violence continues. On February 4, 2026, Israeli attacks killed 23 Palestinians in one of the deadliest days since the pause began [8]. The Rafah crossing remains largely sealed, trapping the sick and wounded and preventing aid from entering, a deliberate policy of slow extermination [9].

2.2. The "Board of Peace": A Blueprint for Ethnic Cleansing

The Trump administration has convened a "Board of Peace" to oversee the "reconstruction" of Gaza. This is a transparent fraud. The board, which includes no Palestinian representation, is a vehicle for the corporate takeover and ethnic cleansing of the Gaza Strip.

• Forced Displacement: The plan, spearheaded by Jared Kushner, treats Gaza as vacant beachfront property, proposing luxury resorts and industrial zones to be built over the ruins of Palestinian homes, hospitals, and universities [10, 11].

• Permanent Military Occupation: Leaked documents reveal plans to build a permanent 350-acre U.S. military base for 5,000 soldiers in the ruins of Gaza, cementing the occupation and ensuring Palestinians can never return [12]. This is not reconstruction; it is colonization.

Article 3: Obstruction of Justice (Article 70, Rome Statute)

As the evidence of its criminality becomes undeniable, the Trump administration has launched a direct and unprecedented attack on the International Criminal Court itself, constituting a clear case of Obstruction of Justice. Through Executive Order 14203, the administration has imposed crippling sanctions on ICC judges and prosecutors. These are not symbolic measures. Reports from February 2026 confirm that judges have had their bank accounts frozen, credit cards canceled, and have been effectively turned into civil pariahs for daring to investigate war crimes committed by the U.S. and its allies [13, 14]. This is a desperate attempt by a criminal regime to intimidate the Court and escape accountability.

Conclusion and Final Plea

The evidence is no longer theoretical. The infrastructure for a holocaust is in place in the United States. The ethnic cleansing of Palestine is entering its final, irreversible phase with active U.S. participation. The international system of justice is under direct attack by its most powerful member state. I implore the Office of the Prosecutor to recognize these events for what they are: the final, frantic movements of a fascist regime consolidating its power and committing its most heinous crimes. The time for preliminary examination is over. The moment for intervention is now, before the incinerators are fired up and before the last Palestinian is driven from their land.
