Factual Summary

Dear Office of the Prosecutor,

I am writing as a concerned global citizen to formally request an investigation into potential crimes under the jurisdiction of the International Criminal Court, specifically relating to:

1. Crimes against humanity through the implementation and promotion of Project 2025, a radical restructuring initiative aimed at dismantling civil protections and enabling authoritarian abuses within the United States.

2. Complicity in genocide and war crimes, particularly concerning Donald J. Trump's material and political support of the State of Israel during its ongoing military campaign in Gaza (2023â€“2025), which has resulted in tens of thousands of civilian casualties, including children, journalists, and aid workers.

Evidence and Allegations

A. Project 2025 (Domestic Policy)

Publicly backed by Donald Trump and tied to organizations such as The Heritage Foundation.

Calls for elimination of career civil servants, expanded use of the Insurrection Act, and weaponization of federal agencies.

Legal scholars and former U.S. officials have warned that it enables mass detentions and political repressionâ€”conditions that may constitute crimes against humanity under Article 7 of the Rome Statute.

B. Complicity in Genocide in Gaza (Foreign Policy)

Trump has consistently defended and encouraged Israeli military operations in Gaza, even after international condemnation of mass civilian deaths and war crimes.

Under Trumpâ€™s previous administration, billions in military aid were provided without oversight.

His continued public support has contributed to impunity for systemic destruction of hospitals, refugee camps, and UN schools.

Opening a preliminary investigation into Donald J. Trump’s actions as a facilitator of crimes against humanity and accessory to potential genocide.

Coordinating with states that recognize universal jurisdiction to examine arrest or indictment feasibility should Trump travel abroad.

Treating this case as part of your broader mandate to hold powerful figures accountable regardless of nationality or status.

I understand that the ICC has constraints given U.S. non-membership, but under Article 15 of the Rome Statute, your office has discretion to initiate proprio motu investigations based on credible information.

I am prepared to provide further documentation, recordings, and publicly available statements if needed.
